

STATISTICS ON ECHO FUNDED ACTIONS

FEBRUARY 2015

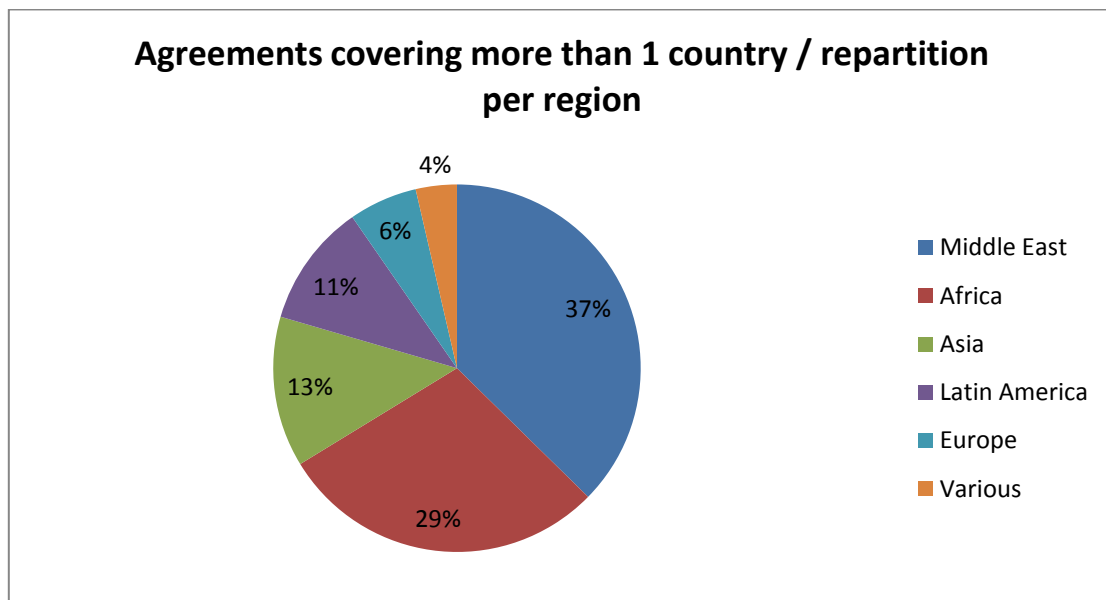
N.B: These statistics are based on data extracted manually from HOPE. The data extracted concerns proposals submitted to ECHO from October 2013 till October 2014.

This document has been developed further to a request from the partners to receive more information on multi-country actions and consortium. The document aims only at providing figures. It does not draw conclusions.

COUNTRIES

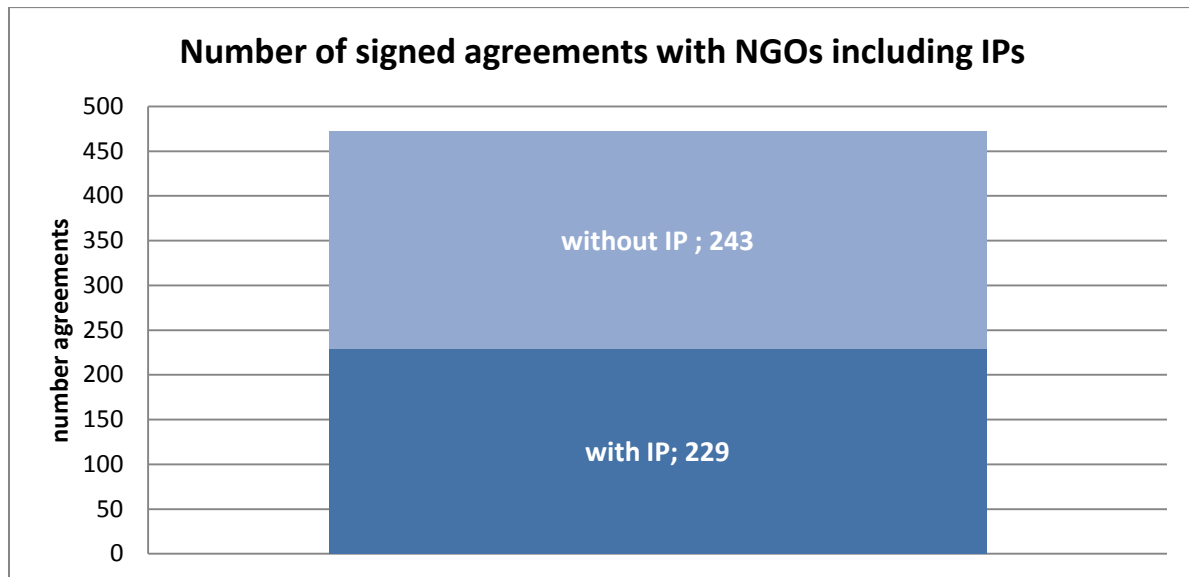
Partners have the feeling that ECHO trends is to increase the number of multi-country agreements.

- Number of proposals with more than 1 country: **138 out of 1299** (including NGOs/IOs/UN) **(10.6%)**
- Number of agreements with more than 1 country: **80 out of 704** (compared to 78 out of 766 in 2013)
- Percentage of agreements with more than 1 country compared to the total number of actions funded: **11.3%** (compared to 10% in 2013)



IMPLEMENTING PARTNERS

Number of signed agreements **with NGOs** including Implementing Partners. Out of 472 agreements, **229 actions (48%)** are implemented with the support of implementing partners (FPA or non FPA partners)



CONSORTIUM

The definition used for the term consortium for these statistics are the agreements signed with NGOs which include implementing partners which FPA partners.

According to 2014 figures, **74 actions out of 472** included at least one FPA partners. Amongst those 74 actions, **17** were submitted by family members (e.g. Red Cross partners, MDM members, etc.) The latter are therefore not considered as consortium.

The percentage of signed agreements including at least one FPA partner not belonging to the same family of the lead applicant: **12% (= 57/472)**

List of countries where the "consortia" have been implemented, including the indicative percentage of consortium compared to the number of actions in the same country and the number of FPA partners involved in the consortium.
